

ORDINANCE LEVYING AND ASSESSING TAXES OF
BENSENVILLE FIRE PROTECTION DISTRICT No. 2
DUPAGE AND COOK COUNTIES, ILLINOIS FOR 2017

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Bensenville Fire Protection District No. 2 as follows:

Section One: That the sum of **FOUR MILLION THREE HUNDRED ELEVEN THOUSAND DOLLARS**. (\$4,311,000.00) be assessed and levied from and against all taxable property within the limits of the said Bensenville Fire Protection District No. 2 as the same is assessed and equalized for State and County purposes for the current year, 2017.

The specific amount hereby levied for each object and purpose is set forth under the column entitled "Amount to Be Raised by Tax Levy," as follows:

AMOUNT TO BE RAISED BY TAX LEVY:

CORPORATE FUND

Corporate Fund Levy \$1,690,000

The foregoing amount is hereby levied for general corporate purposes pursuant to the provisions of 70 ILCS 705/14.

AMBULANCE FUND

Ambulance Fund Levy \$1,570,000

The foregoing amount is hereby levied for ambulance expense purposes pursuant to the provisions of 70 ILCS 705/22.

RESCUE FUND

Rescue Fund Levy \$41,000

The foregoing amount is hereby levied for emergency and rescue expense purposes pursuant to the provisions of 70 ILCS 705/24.

FIREFIGHTER PENSION FUND

Firefighters' Pension Fund Levy \$450,000

The foregoing amount is hereby levied for firefighter pension fund purposes pursuant to the provisions of 40 ILCS 5/4-118 (P.A. 93-0689).

NON-CAPPED FIREFIGHTER PENSION FUND

Firefighters' Pension Fund Levy due to H.B. 599 \$250,000

The foregoing amount is hereby levied for firefighter pension fund purposes pursuant to the provisions of 40 ILCS 5/4-118 and H.B. 599 (P.A. 93-0689).

IMRF FUND

IMRF Fund Levy \$10,000

The foregoing amount is hereby levied for IMRF fund purposes pursuant to the provisions of 40 ILCS 5/7-171.

FICA FUND

FICA Fund Levy \$30,000

The foregoing amount is hereby levied for FICA fund purposes pursuant to the provisions of 65 ILCS 5/21-114.

TORT IMMUNITY FUND

Tort Immunity Fund Levy \$235,000

The foregoing amount is hereby levied for tort immunity purposes pursuant to the provisions of 745 ILCS 14/9-147.

AUDIT FUND

Audit Fund Levy \$5,000

The foregoing amount is hereby levied for audit expense purposes pursuant to the provisions of 50 ILCS 314/9.

MEDICARE FUND

Medicare Fund Levy \$30,000

The foregoing amount is hereby levied for audit expense purposes pursuant to the provisions of 40 ILCS 5/21-110.1.
